- i) "Year" means the period commencing from 1st April and ending with 31st March of every year.

MEMBERSHIP

A member of the trust is a person who:-

- a) has been admitted to the trust according to its rules and regulations, and;
- b) has signed on the roll or register or list of members of the trust, and;
- c) has not resigned in accordance with the rules and regulations of the trust, and;
- d) The discretions / authority of the Author / settlor will be final concerning the grant or refusal of admission to a person as trustee.

RETIREMENT OF A TRUSTEE

A trustee generally retires from his office in following circumstances:-

- i) on extinction of trust;
- ii) on completion of his duties under the trust;
- iii) by resignation or relinquishment of his office ; with the consent of Author / settler of the trust;
- iv) by such means as may be prescribed under the trust-deed;
- v) by special resolution passed by no confidence motion in a special meeting with the consent of President & any two trustee of the trust;
- vi) On being done activities / participating which are against the aims and objects of the trust;
- vii) On being passed disciplinary action in a special meeting of the trust by the President.

RE-ADMISSION

When the office of the trustee falls vacant due to any reason, a new trustee shall be appointed by the Author or president.

TERMINATION OF MEMBERS

- III. On being mentally defected, or
- IV. On being renounced the world, or
- V. On misconduct with any member/trustee of the trust, or
- VI. On being declared as "insolvent", or
- VII. On doing or attempt to act against the aims or objects of the trust, or
- VIII. If the member / trustee has been declared convict by the court, or

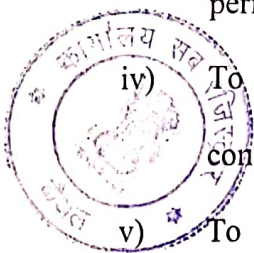

- IX. If the member / trustee steal, purloin, or embezzle any money or property or willfully and maliciously destroy or injure any property of trust.

If any trustee / member found guilty of any one cause mentioned above, then the Author or President of the trust will be empowered to terminate him / her after giving him written notice of one week.

RIGHTS, DUTIES AND RESPONSIBILITIES OF THE TRUSTEES

- i) To elect member(s) / office-bearers of the trust.
- ii) To preserve, maintain and develop the movable and immovable properties and funds of the Trust.
- iii) To plan, discuss and approve the master budget, annual budgets and periodical budgets.



- iv) To frame and supervise the scheme of donations, collections, contributions, programmes, seminars etc.

- v) To incur any expenses in general and necessary to execute, administer, manage or supervise all the activities of the trust.

- vi) To accept donations / grants / subsidy and gifts etc. of any property related to the trust.

- vii) To delegate powers to the members by forming committee / sub-committee(s) in furtherance of the objects of the trust subject to the approval of the President.

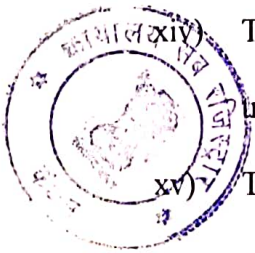

- viii) To consider, discuss and pass the **"Master Budget, annual budgets and periodical budgets"** of the Trust.

- xi) To purchase or take on hire any vehicle for the smooth & well running of the trust.
- xii) To organize camps, exhibitions, tours, competitions, programmes, seminars, symposiums etc. from time to time.
- xiii) To call special meetings for urgent matters.
- xiv) To open bank/post-office account or accounts in the name of the trust and to deposit and withdraw funds as and when required.
- xv) To spend any portion of the corpus or the income of the trust for purchasing any land or vehicles or building or constructing any building for and in the name of the trust for the purpose of carrying out, promoting and executing the objects of the trust.
- xvi) To sell, exchange or transfer any property of the trust in its best interest with prior approval in special meeting by passing a "Special Resolution".
- xvii) To make proper arrangement for proper custody, upkeep, repair and maintenance of the properties and assets of the trust.

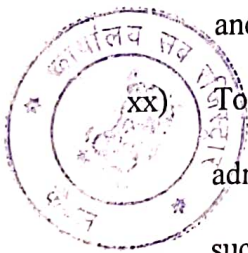

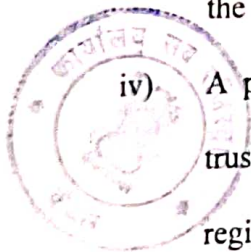

their performance. To appoint and dismiss from service as and when it deems necessary.

MEETING

- i) The annual general meeting of the trust shall be held at least once in every year.

b) **Rights to vote:**


Every member of a trust (except patron and member society / trust / association) is entitled to vote in all the special, annual and general meetings.

The accounting year of the trust shall be financial year commencing from 1st day of April and ending on 31st day of March, next year.


REIMBURSEMENT OF EXPENSES AND REMUNERATION


